

### **SMART2™** LiteALL™ Features & Operation



The SMART2<sup>TM</sup> LiteALL<sup>TM</sup> module has been specifically designed for use with the Shur-Co<sup>®</sup> exclusive SMART2<sup>TM</sup> wireless remote. The module has two outputs which operate independently using the integrated push buttons and has the option of linking the two outputs when controlled via the SMART2<sup>TM</sup> remote.

Utilizing optional output splitters, up to four high-intensity Shur-Co® LED work lights can be connected to each output. Also available are output extension cables, conveniently allowing the high-intensity LED work lights to be mounted anywhere you need them. The SMART2 $^{\text{TM}}$  LiteALL $^{\text{TM}}$  is a valuable addition to the Shur-Co® SMARTrailer $^{\text{TM}}$ .

- The Shur-Co® SMART2™ LiteALL™ control module has two output channels. They can be controlled independently or together in linked mode, using the integrated push buttons.
- Output splitters are available, allowing up to four high-intensity LED work lights to be connected to each output.
- Extension cables are available, allowing convenient and useful mounting options for work lights and other devices.
- The control module is quick and easy to introduce to an additional SMART2™ remote.
- Using your SMART2™ remote, you can control multiple SMART2™ LiteALL™ modules. You can assign custom names to each module and assign custom names to both outputs on each module.

### SMART2™ LiteALL™ Operation:


- When the SMART2™ LiteALL™ module is connected to power, the two output LEDs on the module will turn on for two seconds, indicating the module is on. While OUTPUT A is turned on, the OUTPUT A LED will be lit. While OUTPUT B is turned on, the OUTPUT B LED will be lit.
- To manually control the module, simply press the OUTPUT A button on the module to toggle the device(s) connected to the OUTPUT A channel. Press the OUTPUT B button on the module to toggle the device(s) connected to the OUTPUT B channel.
- To remotely control the LiteALL<sup>™</sup> module after it has been introduced to the SMART2<sup>™</sup> remote, select the LiteALL<sup>™</sup> module from the main menu on the remote screen.





Press either operational button directly under the remote screen to simultaneously toggle both outputs on or off.








### 1120504 LiteALL™ Junction Box Kit

Allows for splicing into 12V power and ground connection on non-SMÄRTwire™ 4500 Series systems (remote systems only).

Includes four 6-ga. x 1/4" stud ring terminals and 3' of 6-ga. wire.






STEP 1: Review wiring diagram. Determine mounting location for LiteALL™ control module. If SMART2™ remote will be used to operate module, it is recommended to locate module where user will have direct line of sight to module while operating remote.

**NOTE:** Keep in mind that power cable on module is 8' long and must be connected to 12 volts.


If LiteALL™ control module is not being hooked up to either a Shur-Co® junction box or SMARTwire™ junction block, it is owner's responsibility to select appropriate 12-volt DC power connection that does not compromise any potential system operation.

If you have any questions about connecting LiteALL's control module to your equipment, contact equipment manufacturer.


STEP 2: If power and/or output cables are to pass THROUGH mounting surface (.150" max. wall thickness), use 1 1/4" hole saw to cut hole directly behind module. Pass cables through grommet ♥, then insert grommet into hole.



STEP 3: If power and/or output cables are NOT being routed through mounting surface, route through cutouts in bottom sidewall of LiteALL™ control module.



Fasten LiteALL™ control module to mounting surface with four self-drilling screws ③. Spacers ⑤ are optional.





STEP 5: Route power cable from LiteALL™ module to power source. Refer to wiring diagram.

STEP 6: Disconnect power from power source. Prepare power cable for connection to power source and connect as follows:

#### POWER SUPPLIED FROM SMARTWIRE™ CONNECTION

• Connect two-pole connector on LiteaLL™ power cable to SMARTwire™ adapter cable. Seal connection with heat shrink or electrical tape.





### POWER SUPPLIED FROM SHUR-CO® SEALED JUNCTION BOX

Remove and discard two-pole connector on end of power cable.



- If all grommeted ports in junction box are used, drill 21/32" hole in box and install additional grommet ①.
- Puncture nipple of grommet with pen or small punch and route power cable into box.
- Crimp appropriate ring terminals to black and white wires.
  - If using existing Shur-Co<sup>®</sup> junction box with circuit breaker, crimp #10 ring terminal onto white wire and 1/4" ring terminal onto black wire.
  - If junction box does not have circuit breaker, crimp 1/4" ring terminals to both white and black wires.

NOTE: If wire ends must be re-stripped, strip only enough wire insulation to install ring terminals. Insert bare wire into ring terminals and crimp securely.




STEP 8: Use wire clips ② and/or cable ties to secure output cables. Use drill and #2 Phillips bit to self drill screws ③ and secure wire clips.





STEP 1: Use 1/2" and 9/16" combination wrenches to assemble LED work light mounting brackets. Use hardware found in LED work light boxes as shown.



STEP 2: Drill 13/32" hole in desired location for work light mounting stud. Insert stud through hole and use 11/16" combination wrench to fasten lock washer and mounting nut.




If work light cable is to be passed through mounting

surface, use 11/16" hole saw to cut hole for grommet

STEP 4: Route work light cable to LiteALL™ control module. Verify cable routing before securing cable. If 20' extension cable ① is needed, route extension cable between LiteAll™ control module and work light cables. Verify that molded two-way trailer connector will fit complementing connector; black wire to black wire, white wire to white wire. If not, use other end of extension cable. Connect two-way trailer connectors.





STEP 5: Use wire clips ② and/or cable ties to secure work light and extension cables. Use drill and #2 Phillips bit to self-drill screws ② to secure wire clips.




STEP 6: Coil and secure any excess cable with cable ties.

STEP 7: Repeat steps above for each additional work light. If more than one work light is to be connected to either LiteALL™ module output, insert output splitter ③.

Pairing your devices (introducing the remote to the LiteALL™): Each remote and LiteALL™ receiver module has a unique security code to prevent unauthorized operation. Before a remote can operate a LiteALL™ module, they must be paired, or introduced. This is typically done at the factory before shipping. If the remote must be introduced to the LiteALL™ module, or if a second remote is being added to the module, follow the instructions below.

**NOTE**: Refer to SMART2<sup>™</sup> remote Owner's Manual for complete remote instructions.

- **STEP 1.** Make sure LiteALL™ control module is connected to power.
- STEP 2: From Main Menu on SMART2™ remote, arrow to Setup option and press Select.








STEP 8: Remote will display INFO SAVED to confirm that remote has been successfully introduced to LiteALL™.

**STEP 9:** Repeat steps 1 to 8 for any additional remotes to be programmed to LiteALL™ module.

Setting operating mode (linked or unlinked outputs):

Using the SMART2™ remote, you have the option of linking OUTPUT A and B so they turn on or off together when using the remote. This is referred to as LINKED MODE.

At any time, the remote can be set to operate the LiteALL™ module in LINKED or UNLINKED mode by following these instructions:







STEP 1: From Main Menu, arrow down to Setup and press Select.




